

Cervical Cancer Quality Performance Indicators

Patients diagnosed between October 2017 and September 2020

About this release

This release by Public Health Scotland (PHS) presents performance against the National Cervical Cancer Quality Performance Indicators (QPIs) in the Cancer QPIs dashboard held within the Scottish Cancer Registry and Intelligence Service (SCRIS).

Main Points

- There were 273 women diagnosed with Cervical Cancer in Scotland over the period Oct 19 to Sep 20. This is a reduction from previous years (310 and 309 women were diagnosed in Oct 18 to Sep 19 and Oct 17 to Sep 18, respectively).
- Preliminary examination of Oct 19 to Sep 20 data is variable between networks and it is expected that the impact of COVID will be clarified in future cohorts.
- At Scotland level for Oct 19 to Sep 20, the target was met in five of the eight indicators with three below target.
- Of the three indicators below target in Oct 19 to Sep 20, two were narrowly missed and perhaps demonstrates that clinical standards have largely been met despite the start of the pandemic.

NHS Boards are required to report these indicators against a clinically agreed indicator specific target as part of the mandatory national cancer quality programme. They have been developed collaboratively by the <u>North Cancer Alliance</u>, <u>South East</u> <u>Scotland Cancer Network</u>, <u>West of Scotland Cancer Network</u>, <u>Healthcare Improvement Scotland</u> and PHS.
