# City Staff Report

**Subject:** Cannabis Retail License for 308 McLean Street.

#### **Purpose**

To review a retail cannabis application for 308 McLean Street and to recommend to the Liquor and Cannabis Regulation Branch (LCRB) whether or not a license should be issued to the applicant.

### Summary

- Owner of the Billy Barker Casino and Hotel, Brad Kotzer has applied to the LCRB to obtain a Nonmedical Cannabis Retail Store License.
- As part of this application, the LCRB requires that the Local Government (the City) provide the Branch with a recommendation and comments on whether or not to permit the issuance of a Non-medical Cannabis Retail Store License.
- Public consultation in the form of direct mailing to tenants and property owners was undertaken and as of the time of report writing, no comments or objections were received.
- The proposed site meets zoning requirements.

#### Recommendation

THAT Council provides the following recommendation to LCRB:

Be it resolved that:

- 1. The City of Quesnel Council has undertaken sufficient efforts to gather public input for the community in the immediate vicinity of the proposed endorsement service area by direct mailing to all tenants and property owners within 100 meters of the subject property.
- 2. The City of Quesnel Council recommends the issuance of a Non-medical Cannabis Retail Store License to 1412 Holdings Limited at 308 McLean Street for the following reasons:
  - Adequate efforts were undertaken to gather the views of the public for the proposal and none were submitted;
  - The location is suitable and properly zoned for the use intended and meets the required setbacks from schools, playgrounds, parks and residents;
  - There is no negative community impacts anticipated with a legalized and controlled retail facility;
  - No views from the public were provided to the City following notice consultation of 58 tenants and property owners.

## **Background**

#### Proposal

• The Applicant's proposal is to operate a Cannabis Retail Store at an existing unit of 308 McLean Street. This unit was previously used as a liquor store. The site is within the area permitting the use of Cannabis Retail Sales and meets the required setbacks as per Zoning Bylaw No. 1662.

#### Public Consultation

- Notices of the application were sent to residents and property owners within a 100 meter distance of the subject property. The notice described the proposed cannabis retail store and provided the opportunity to submit written comment to be included in this report.
- Notices were mailed Thursday, January 31, 2019.
- No written submissions were received by City staff.
- See the Mail-out Map attachment for properties notified including tenants and owners.
- A total of 58 notices were sent.

#### Discussion/Comments

- The Non-medical Cannabis Retail Store License application requires that Council undergo public consultation and provide a recommendation on the application.
- Council must consider:
  - The location of the establishment.
- Council must provide a recommendation with comments on:
  - The views of the local government on the impact on the community if the application is approved.
  - The view of residents and a description of the method used to gather views.
  - The recommendations (including whether or not the application be approved) and the reasons on which they are based.
- Below, Planning Staff have included some general comments on the prescribed items:
  - Location: the proposed store would be located at 308 McLean Street, also known as the Billy Barker Casino and Hotel. There are no parks, schools or playgrounds within 100 meters of the front entrance of the proposed store. There are no residentially zoned properties located within 25 meters of the proposed store. The use of Cannabis Retail Sales is a permitted use at 308 McLean Street.
  - 2. <u>The impact on the community</u>: it is anticipated that there will be no negative community impacts with a legalized controlled facility where all location regulations are met and no public written submissions have been received as of this report date.
  - 3. The view of residents: No written submissions have been received as of this report date.
  - 4. <u>Description of method used to gather views</u>: The method used to gather views included 58 mailed notices to all tenants and property owners within 100 meters of subject property. The notice included a simple description of the application, information on how to submit comments regarding the application and a location map of the subject property.
